



## Doggie Daycare Contract

We have provided our doggie daycare contract so that you may further understand what is required of you and your dog before enrolling in daycare. You will be asked to read and sign this contract at the time of your dog's acceptance into our daycare program.

I, \_\_\_\_\_ (owner), hereby certify that my dog(s) \_\_\_\_\_ is/are in good health and have not been ill with any communicable condition in the last 30 days. I further certify that my dog(s) have not harmed or shown any aggression or threatening behavior towards any person or any other dog. Pet's Best Friend, Inc. agrees to exercise due and reasonable care in the handling of dogs, and in keeping the facility properly enclosed, safe and sanitary. All dogs are cared for by Pet's Best Friend, Inc. without liability on Pet's Best Friend, Inc. behalf for loss or damage from disease, theft, fire, death, escape, injury or harm to persons, other dogs, or property by said dog(s), or for other unavoidable causes.

### **I HAVE READ AND UNDERSTAND THE FOLLOWING:**

- \_\_\_\_ 1. I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are in the care of Pet's Best Friend, Inc. and release Pet's Best Friend, Inc. of any liability arising from my dog's attendance and participation at the daycare.
- \_\_\_\_ 2. I recognize that there are inherent risks of illness or injury when animals are allowed to be in close contact with one another. Such risks include, but are not limited to, problems resulting from rough play and canine cough (doggie colds).
- \_\_\_\_ 3. I further understand and agree that in admitting my dog(s) to Pet's Best Friend, Inc., the staff at Pet's Best Friend, Inc. have relied on my representation that my dog(s) is/are in good health or have not harmed or shown aggressive or threatening behavior towards any person or any other dog.
- \_\_\_\_ 4. I understand that my dog(s) will be playing in open areas with other dogs and accept when dogs play in groups, they will get dirty, and nicks and scratches may occur, as well as any other inherent risks that are involved and I hereby release Pet's Best Friend, Inc. of any liability; I further understand and agree that Pet's Best Friend, Inc. staff will not be liable for any or all problems which may develop.
- \_\_\_\_ 5. I further understand and agree that any problems which develop with my dog(s) will be treated as deemed appropriate by Pet's Best Friend, Inc. staff at their sole discretion, and that I assume full financial responsibility for any and all expenses involved, if I or Pet's Best Friend, Inc. decides to obtain medical treatment.
- \_\_\_\_ 6. I accept that if my dog causes any excessive damage to the facility that I could be asked to pay for repairs.
- \_\_\_\_ 7. I understand that if my dog is not spayed or neutered by 6 months of age, he/she will not be allowed to participate in daycare with other dogs.
- \_\_\_\_ 8. I further understand that if my dog shows any signs of aggression towards other dogs, their acceptance in daycare will be reevaluated. They will be given between 1 and 3 chances, depending on the situation surrounding the aggression, before they are forbidden to participate in daycare.
- \_\_\_\_ 9. Human aggressive dogs, or dogs with fear issues, will not be allowed to stay at Pet's Best Friend, Inc. daycare.
- \_\_\_\_ 10. As a responsible pet owner, I promise to keep my dog(s) current on all vaccines, including bordetella, distemper, rabies and flu and all other state required vaccines. Pet's Best Friend, Inc. is not responsible for informing you of due dates on vaccines, nor will Pet's Best Friend, Inc. provide vaccine records for any reason. If a vaccine becomes past due, the dog will not be allowed to attend doggie daycare until 10 days after the vaccine is administered.
- \_\_\_\_ 11. I understand that daycare packages are non-refundable except in the case of death of dog or a debilitating condition that prevents his/her return to daycare.

**DAYS AND HOURS:** Monday through Friday from 7:30 am to 5:30 pm.

**EMERGENCY:** In the event of an emergency, Pet's Best Friend, Inc. staff will attempt to contact the owner. Pet's Best Friend, Inc. may also directly contact the veterinarian on file or any emergency veterinarian of Pet's Best Friend, Inc.'s choice, if the circumstances are deemed such that immediate treatment is necessary. Pet's Best Friend, Inc. staff retains sole discretion in emergency matters, without liability, and the owner of the dog(s) agrees to promptly pay for all medical treatments received.

I hereby release Pet's Best Friend, Inc. of any lawsuits, causes of action, claims and/or demands associated with any action concerning my dog(s).
